## Safety and Human Resources

The IIPP Section of Cal/OSHA's T8CCR3203 as well as numerous other Hazard specific safety orders mandate "training", "re-training", "inform", and other such verbiage as a mandatory requirement of compliance to the orders. The employers challenge is the "how" and to "what effectiveness" outcomes. Ms. Lewis will provide a discussion on the organizational challenges and successes regarding these and related issues. Ms. Lewis will provide clues, tricks and tips on methods of approach and implementation of the process that provides for the dissemination and retention of critical safety information and ideas. Should the requisite employee information not be retained and converted into action and performance, Ms. Lewis will visit other means and methods to retrain and, where necessary, sanction employees for non-compliance to organizational rules of safety even within the parameters of an MOU.
