About the Speaker...

Steve's current position is as the Safety and Training Officer for the Risk Management Division of the Orange County Sheriff's Department. He previously worked as a Paramedic/Firefighter in Los Angeles for over 10 years. He was also an Emergency Room Nurse Manager and Hospital Administrator for 10 years in the specific fields of Emergency Medicine, Cardiology and Trauma. He is an Advanced Cardiology Life Support Instructor and a POST Instructor for CPR/AED/First Aid. He

has worked in all levels of the Incident Command System. His impressive educational background includes the study of Biology/Pre-Hospital Medicine at the UCLA David Geffen School of Medicine, Fire Science at Rancho Santiago College, and the Firefighter/Officer Academy with the Orange County Fire Authority. He has completed clinical education in Emergency Services from USC University Hospital, Trauma/Critical Care at Long Beach Memorial Hospital, OB/GYN at Daniel Freeman Hospital and Pre-Hospital Care with the County of Los Angeles. Outside of work, he has a passion for bike riding and outdoor activities.

Orange County Emergency Medical Services (EMS) / Law Enforcement Narcan (Naloxone)

In late 2017, the Federal Government has declared the opioid epidemic a National Emergency. In the last several years, U.S. Law Enforcement has seen a dramatic increase in the availability of dangerous synthetic opioids. A large majority of these synthetic opioids are structural derivatives of the synthetic drug "fentanyl." Fentanyl is a synthetic opioid currently listed as a Schedule II prescription drug that mimics the effects of morphine in the human body, but has potency 100 times that of morphine. Due to the high potency and availability of fentanyl, both transnational and domestic criminal organizations are increasingly utilizing these dangerous synthetic opioids as an adulterant in heroin and other controlled substances. The presence of these synthetic opioids in the illicit U.S. drug market is extremely concerning as the potency of these drugs has led to a significant increase in overdose incidents and overdose related deaths throughout the nation.

Annual Cal/OSHA Updates

Juliann Sum was appointed Chief of Cal/OSHA by Governor Jerry Brown in December 2014. She had served as acting Cal/OSHA chief since September 2013. Prior to that, she was a special advisor to Christine Baker, director of the state's Department of Industrial Relations (DIR), which oversees Cal/OSHA. Before joining DIR in 2012, she was the project director with University of California at Berkeley's Institute for Research on Labor and Employment, and an attorney and industrial hygienist with UC Berkeley's Labor Occupational Health Program. Her extensive experience also includes work as an associate attorney with the Environmental Law Foundation, Litigation Associate with Carroll, Burdick & McDonough, and as industrial hygienist and business representative with the International Brotherhood of Electrical Workers Local 1245. Ms. Sum earned a Juris Doctor degree from University of California, Hastings College of the Law, a Master of Science degree in environmental health sciences from the Harvard School of Public Health and a Bachelor of Science degree in biophysics from Brown University.
